These are group prices and, for most categories, are lower than today's individual prices. I will be monitoring the prices throughout the life of the bookings to assure that the prices you get are the lowest available. Deposits are totally refundable up until final payment date of June 27, 2011.

I did not include travel insurance as we generally use a third party for this; cost is generally about 5% of the vacation price.

With this group comes 4 Amenity Points. We can select from a series of amenities including a cocktail party, bottle of wine, onboard credit, photos, etc. I chose \$50 per cabin but we can re-visit if you wish. I find this satisfies most people! We can use the TCs to buy more points if you wish...

Reasons to book early: better cabin assignment, better chance at dining time preference. Deposit is 100% refundable.

I do have these prices until January at which time we will need to decide if you wish to add a \$50 per cabin bulk deposit to hold cabins and prices.
