The March 10, 2024 DVFA Executive meeting was called to order at 10:00 AM by President Ron O'Neal at the Delaware State Fire School complex in Dover.

#### **Special Guests:**

CFSI Executive Director Bill Webb spoke on the activities of the CFSI in Washington, DC. He encouraged the DVFA membership to attend the annual CFSI dinner and symposium this year. Delaware has always been well represented at this event and by being so, they get a discounted ticket price. This is the last year at the Washington Hilton on April 29<sup>th</sup>. In 2025 they will be moving to the Marriott Marquis on Massachusetts Ave. in Washington, DC. Any complaints on the dinner should be directed to the DVFA officers, since they chose the menu for this year.

#### **Report of Officers**

#### President O'Neal: (copied and pasted from email report)

I want to thank everyone for getting up early this morning to attend this Executive meeting.

To start off, as you probably know already, the DVFA Office move has been completed and we are happy to say the office is up and running. I want to specifically thank Terry Whitham, Warren Jones, Jay Jones, Pablo Reyes and Tom DiCristofaro for their work in getting this task accomplished. If you haven't been there, this location contains an office area as well as a separate small conference room that can be utilized for meetings. This is certainly an upgrade to the Bradford Street location and one that will serve the DVFA well for many years to come.

As Executive Director Webb stated, the CFSI dinner this year has moved to Monday, April 29, to be held, as in the past years, at the Washington Hilton. Ticket prices have been set for Delaware attendees and are available thru the DVFA office. Please do not purchase your tickets thru the CFSI website, you will not receive the Delaware ticket price if you do. While realizing the ticket costs along with the date change may have an impact on those attending, we still need to promote this event whenever and wherever possible, especially at all County

meetings and we are relying on the DVFA Directors to lead this effort. This is the premiere fundraiser for CFSI and the DVFA has consistently had the greatest attendance of any other State and our representation is extremely important. Since 2015, organizations in the State of Delaware have received funding from 54 different grants through both the AFG and SAFER grant programs, adding up to a total of approximately, \$12,815,000, and that includes the \$1,252,000 Recruitment & Retention SAFER grant received by the DVFA in 2022. As you can see, this is an important cause and we need to continue to support this vital fundraising event. Not only for the grant monies aspect, but our attendance also helps keep the Delaware Fire Service involved with a "seat at the table", giving us visibility and enabling us to be a part of discussions of importance.

This is an extremely busy time in Legislative Hall, Executive Mgr. Jones and the Law & Legislative Committee doing a great job in keeping an eye on multiple pieces of Legislation being proposed and working their way through the process. I'm extremely excited to see the Delaware Fire Caucus come together as we have our first kickoff meeting this coming week. I know Mr. Jones will have further details in his report but I want to give a huge shout-out to Jay for his idea of this Caucus and his work in putting this together. I think this will be a great addition to the "tool-box" of the Fire Service to have this working group in Legislative Hall.

I'm happy and honored to say that the Fallen Firefighter Memorial Committee that we put together is doing a great job and has scheduled the first of a number of memorial services that will take place this year, to honor those who's name appear on the Firefighter Memorial on the Green in Dover. The first will take place on Saturday, April 27 at 10am, to honor Laura Madara of Station 88, Selbyville. Committee Chair Bill Tobin and his committee are working with the Madara family and with the City of Dover to schedule this dignified ceremony. Later this year, we will also be honoring John Pridemore from Clayton, and Phil Young from Dover, both of which passed during their work in the Fire Service. All three of those individuals will be honored at the National Fallen Firefighter's Memorial Weekend in Emmitsburg on May 5, 2024. The DVFA will be scheduling at least one bus and possibly two, depending on the number of members who wish to attend this year's memorial. Information will be coming on that event.

The Harrington Fire Company is sponsoring a First Responders Day on April 13, 2024, including a parade, displays, wreath laying and a free dinner for first responders participating in the activities of the day. Registration is due March 1<sup>st</sup>. Warren had originally sent this out on Feb 7 but I would like to have this sent again in order to promote this event. Please spread information regarding this event at the County meeting level as well.

In closing, we are half-way through this administration and it is amazing how quickly time goes by. In reviewing the list of priorities that we put together for the 2023-2024 year, I feel good that we have been able to accomplish a number of tasks on that list. I sincerely appreciate the hard work and dedication by everyone; the Auxiliaries for all the fundraising they do to support the Scholarship program and your companies, thank you so much for your work; the Officers of the DVFA for the time dedicated to this organization, you don't realize how much work there is until you become a part of it. # **Committee Reports**

## Cancer Policy – Deb Lawhead: (copied and pasted from email report)

In August 2021, following enactment of the Delaware "Line of Duty Disability Policies for Certain Emergency Responders," the Department of Human Resources—Insurance Coverage Office secured an insurance policy for certain emergency responders, which provides benefits payable after diagnosis from covered conditions to help offset expenses related to cancer diagnosis.

#### **Eligibility**

Class 1— All Active paid Personnel after three years of Active service.

Class 2— All current Active volunteer Personnel after three years of Active service, retired Active and all Class 1 or Active volunteer Personnel for 60 months after formal cessation of Personnel's status.

#### **Lump Sum Benefit**

#### Class 1 & 2

- \$5,000 Early Stage Cancer Benefit
- \$20,000 Advanced Stage Cancer Benefit
- \$40,000 Life me Lump Sum Total per insured.

It also pay lost wages for those who are paid personnel and volunteer personnel who are working. Diagnosed with Cancer after the Policy Effective Date (1/1/2022)

#### **Funding and Administration**

The administration of this policy and funding are through the Insurance Coverage Office. The Insurance Coverage Office does not pay the claims.

The funds are generated from the premium tax defined in Title 18 §705. Once annually and based on the calculation defined in the statute, the Insurance Coverage Office will receive the funds to purchase the required policy.

## **Claims**

A total of Thirty-Six (36) disability claims have been submi □ed against the policy as of 12/31/2023, in which five (5) of the Thirty Six (36) claims collected lost wages under §6702B (2b) and Twenty-nine (29) claims were paid lump sums under §6702B (1 or 2). Total dollar figure paid by the Insurance company in claims as of 12/31/23 is \$382,671.96

# Advisory to DSFS - Tucker Dempsey: (copied and pasted from email report)

- The fire school has applied for an Assistance to Firefighters Grant for approximately \$500k
- We have scheduled additional officer classes to meet the demand caused by the 709 regulations
- The fire school is still offering in-service training at fire stations, with the exception of officer classes due to the high demand
- The Firefighter 1 & 2 program is in progress and going well
- We have revamped the old recognition program to allow easier tracking of who qualifies as an officer per 709
- Bids close for the foam replacement project soon so we will be notifying the companies who signed up for it
- So far our state budget request is largely intact, with the exception of an additional Administrative Assistant we asked for
- Several of us went to Texas and Arkansas to look at burn buildings since we are in the process of designing a new one
- Companies need to look at the pending OSHA regulations that could potentially have a significant impact to their operations

# Recruitment & Retention - Warren Jones: (copied and pasted from email report)

DVFA awarded a SAFER Grant for Recruitment and Retention on December 13, 2022.

The parts of the grand are Marketing, Scholarships, Sub-grants, 1582 physicals and a set of Fire Gear for every new volunteer firefighter up to 30 sets per year. Warren Jones is the administrator of the grant. I do all the administrative items with FEMA, reports, filling for payments, etc. Jeff Brown is the co-administrator and handles the company communications for the Sub-grants, Physicals, Gear, etc.

We put the Marketing part of the grant out for bids and awarded the marketing to First Arriving. In addition to the marketing we had to develop a mechanism for the sub-grants. Jeff Brown developed a grant applications and award process.

We had a few bumps in the road especially with the 1582 physicals. First, we could not find anyone who could do the 1582 physicals and cover the State of Delaware. We finally found a company but they did not know all the parts of the 1582 physicals. We had to track down information from FEMA give it to them. That turned out to be nightmare we are still dealing with. They closed all their branches in Delaware and a good many of their physicals were not completed or incorrect. Another company took over for them and they started doing some of the physicals. When we received their invoices they were not in compliant with 1582.

I was scrambling to find someone else when at the November Sussex County Meeting, Ashley Taylor stood up to report her group could do 1582 physicals. For those of you who do not know Ashley she is the daughter of Laurel Fire Chiefs, Jeff Hill.

She has taken that whole process over and it is running smoothly. She will come out to your stations to do the physicals. Ashley bills us \$500 per physical which is allowed by FEMA. She does have a travel charge of \$60 for any company more than 20 miles from her location. I am working on have FEMA cover that charge. We still have some of the mess to clean up from the other two.

#### **Training**

First Arriving just completed a 2 day full day course of training last weekend. Saturday was in Ellendale Sunday was in Delaware City. The course was in 2 parts. The first part was developing a grassroots recruitment campaign and the second part was how to use social media. They were to very good classes. I received good comments from the over 60 people who attended. I want to thank Ellendale and Delaware City for hosting us.

#### Website

On June 6, 2023, the Join Delaware Fire website landing page was launched, serving as the campaign's starting point and providing a dedicated location for capturing leads generated from First Arriving's efforts. The next phase involves expanding the website to include comprehensive sections for all fire companies in the state organized by county. Each Fire company can have their respective websites, social media channels, and contact information included through this website. In order to collect the essential information for each department, a profile form was distributed to all companies across the state. If you have not completed this form your information will not be available on the website. Once the forms are submitted, the gathered details will be promptly incorporated into the website. Additionally, the full website will incorporate a "Why Volunteer" segment, highlighting the opportunities available throughout the state and providing further information on how individuals can engage in volunteering within Delaware

#### Marketing

From July to December, these organic posts and paid advertisements successfully directed traffic to the landing page through trackable links and advertising channels. Additionally, Google Search and Display were introduced, launching in November 2023. In November and December, efforts were focused on coordinating with DART for bus advertising, utilizing photo assets from the video shoot. This included the application of eye-catching King

Kong wraps on DART buses operating in Kent, New Castle County, and Sussex. The bus advertising campaign has commenced.

#### Video's

The kickoff call meeting for the video shoot was held on August 17, 2023, with the filming weekend set for October 28-29, 2023. Throughout this period, numerous calls and emails were exchanged to establish the schedule, organize specific interviews for each participant, and address other logistical matters. The video shoot was executed successfully in October. Final edits were completed in quarter 1 of 2024. Additionally, a collection of photos was taken and shared. These assets, along with the videos, will be integrated into the JoinDelawareFire.com website and the recruitment social media channels. This includes the creation of a YouTube channel and TikTok account to feature the videos and audio. Furthermore, efforts are underway to showcase the content on local news and radio stations. Future plans involve running advertisements on platforms such as Hulu, Pandora, Spotify, TikTok, and local movie theaters across the state, among other initiatives.

#### **Next Phase**

The next phase of the project involves developing and producing recruiter kits customized for County Coordinators to utilize during events and recruitment campaigns within their respective counties. We need County Coordinators, at least 1, I'd like to have 2 in Sussex, one on the east and one on the west. These kits will include tablecloths, pull-up banners, flyers, postcards, business cards, and other relevant handout materials. The main aim of these materials is to capture the interest of potential members by incorporating QR codes and essential details that facilitate easy redirection to the Join Delaware Fire website for submitting applications. With the new assets obtained from the video shoot, the initial designs have been updated to integrate the new images. The printing of these materials is expected to occur in the first quarter of 2024

#### Leads

We have developed substantial leads since August. I will go over the results in a minute. When the leads come in, Jeff Brown sends them to the Fire Chief, the President and the person listing as the membership chair or recruiting person of your company.

We have received 174 leads that ended going out to 35 fire companies.

The breakdown is 5 Auxiliary, 79 EMT, 80 Firefighters, 10 Juniors/cadets

Do all these leads mean we are getting a whole bunch of new members? No! Some people who reply to the lead page are only looking for information. If we end up with 20 % becoming members, this will be good. You have to be prepared. You have to have a group of people in your companies who are willing and know how to do all the work necessary to have a good recruitment and retention program. We can teach you what that is. I spoke with the Deputy Director, Chad Ingram, of the Fire School at the class in Delaware City about putting together a Recruitment and Retention Training Class. I volunteered and he gave me the authorization to put it together.

If you are a member of the NVFC there are stipends available. If you're not a member it only cost \$25 to join. I'll be in Buffalo. If you go, we can hook up and chat about the fire service.

# National Vol. Fire Council: Delegate Bill Betts (copied from written report)

Membership of the NVFC in late December has reached 34,000 members toward their five-year plan of having a membership of 50,000 members. Delaware Directors Jay Jones and Bill Betts would like to encourage our Delaware delegation to join this Association as the more members that they have, the more voice they have in the federal legislature in requesting funding for our departments and FEMA grant funding for AFG and SAFER. Dues are \$21.00 per year, and it includes a \$10,000 AD &D policy from Provident. In addition, there are many free training webinars from Recruitment & Retention, PTSD, Cancer Presumption, to Lithium-lon Batteries and Hazardous Materials. The NVFC also provides its membership with a lot of giveaways such as canned water, drip-drop hydration powder, Fire House Coffee, Gear Giveaways, and many other items.

The NVFC is having its annual summit in Buffalo, NY on June 21<sup>st</sup> and 22<sup>nd</sup> and is offering training stipends to members who qualify. The focus of the Summit is Recruitment & Retention and Firefighter Safety.

#### **Important Action Items:**

The NVFC is heavily involved with a Congressional Campaign to maintain the AFG and SAFER funding for the Fire Service. With the lame duck Congress this fall, and the lack of cooperation on both sides of the aisle, this funding is at a critical point of maintaining our funding for these popular grants.

The NVFC is also heavily involved with webinars and accepting comments on the newly proposed OSHA 1910.156 standard which would put volunteer fire departments under the standard that was originally developed for industrial fire brigades. They have incorporated a load of NFPA standards into this regulation which would make them law if this is passed. Please contact your national congressional delegation to oppose this regulation. It is another financial and time-consuming factor that will adversely affect the volunteer fire service.
