

# **DVFA EXECUTIVE MEETING**

# Delaware State Fire School December 11, 2022

The December 11, 2022 DVFA Executive meeting was called to order at 10:00 AM by President Ken Ryder at the Delaware State Fire School complex in Dover.

#### **Report of Officers**

#### President Ryder: (copied and pasted from written report)

This will be to cover some of my thoughts about current and upcoming events since our November 29<sup>th</sup> officers meeting in Felton. I've finished posting my events, hours and miles travelled on my activity report. It seems like travelling has been above average this past quarter. I'd contribute that to a lessening in concern about COVID for most of us. However, we are at the beginning of December and it appears that things are continuing to worsen with the flu,

RSV and COVID cases showing signs of significant increases again. Since this is the 2<sup>nd</sup> week in December, we are getting into the holiday season...and of course official winter is the 21st.

R&R....Continues to be an item of importance during this year. The change in our tax credit legislation has passed and we will actually have that credit on our 2022 tax returns. Warren Jones will be working with Jeff Brown to get the programs up and running at Fire School. In addition, Warren secured the 4-year SAFER grant for \$1.251M and is working on the logistics of how this will work and be incorporated into other programs at DSFS. This is only the beginning we must continue to seek out and identify thoughts, ideas and other means that may help reverse the societal changes that our system of volunteerism has become a victim of. We must continue looking for solutions because failure for the volunteer fire service is not an option!

As we approach the DVFA Exec. Meeting in Dover this Sunday one item under committee reports will be the "final draft" of Reg. 709. The committee has reviewed, remolded, and rewritten Reg. 709 to be the document that we all can support going forward. This committee has worked in person, over the phone and by zoom meetings to get to this point. They have a document "once completed" that all can agree on that is in the best interest of the fire service. I cannot express my thanks and gratitude enough for all their time & efforts in this endeavor.

Our December 2<sup>nd</sup> President's and staff meeting with the Governor went really well. It looks like we are headed back to the grant-in-aid process with the 2 chairs once things settle down in the legislature after the elections.

The Surf Tag situation has been resolved for this year at least. They are currently on sale and available with no limit basis this year. All 3 Presidents have the stamps and are available to work with each company to get theirs completed.

My Presidential year needs to be adjusted by a planned family vacation. When you do something like this it is bound to land on or effect at least one thing on our busy calendars. So "in throwing the dart" at the board the event effected the most is going to be our March DVFA meeting on Sunday, March 12<sup>th</sup>. I'll be travelling from March 5<sup>th</sup> through March 12<sup>th</sup>. Some of you are already aware of this due to the discussions we have been having about it. Vice President Ron O'Neal will be in the President's position and chairing the March meeting in my absence.

One more thing to squeeze in here is my phone call with President Biden. This story goes something like this, Jay called me on the afternoon of October 11<sup>th</sup> telling me he had just gotten a call from the President's office. He told me that the President was going to be calling me, he wasn't sure when, but I should be on standby for a call on my cell phone. I replied "Okay, I'll be looking forward to getting the call." After a few minutes Jay called back and "asked if something was wrong with my cell phone?" I advised that "I didn't think so since I was in a good place for reception." He said "The President is trying to reach you but he can't get through." At this point I was becoming a little suspicious that Jay might be "pulling my chain" but I went along with what he was saying. He advised me to "stop whatever I was doing and call the President at this number." "Okay, I'll hang up and call that number." So I tried the number, it rang twice before a feminine voice answered. I had originally extended an invitation for him to be here in person but as his staff advised that his schedule was full and he would be tied up in Washington with events for this weekend. Follow me now. We aren't done yet.

Story continues. Next chapter. On Monday evening, December 5<sup>th</sup>, Jay gets an email from the White House Social Office. Jay then calls me to let me know of the email that has arrived and forwards it to me to review. It states" Please see the invitation below, inviting me and a guest, for a Holiday Reception to be held at the White House on Saturday, December 10th at 2:30 pm." This is "out of the blue" and totally unexpected!! My wife declined attending as guest as she felt it should be someone from the DVFA. After this decision I in turn asked Jay if he was able to attend with me. His answer was yes…he felt his schedule would allow him to participate. So we agreed that's what we would plan to do.

However he later advised that his schedule had changed and he wouldn't be able to make the trip. So we ask Warren if he was able to attend. Warren said he was able to go so we agreed this would now be Plan A.

On Saturday morning, December 10<sup>th</sup>, your DVFA President and Administrative Assistant made the trip to the White House for a 2:30 pm Holiday Reception. Once we were able to get over the drive, the parking, the security check-ins and the screening, the rest was easy. What as experience! To be able to attend and represent the Delaware Volunteer Fire Service was quite an honor. My "Thanks to all of you" for electing me as your President and allowing me to represent you at the White House in Washington, DC. I'll not say end of story...who knows this year is young yet we might have to add another chapter!

I'll summarize my activity report by items noted....for events attended 34, travelled 1278 miles...111 hours inservice. These are the ones recorded for this quarter.... but I know many miles, time and hours get lost in the shuffle.

**Special Presentation:** Video from United States President Joseph R. Biden thanking the volunteer fire service for what you do on a daily basis. He praised the men and women of the fire service and promised to always have our backs.

## First Vice President O'Neal: (copied and pasted from written report)

Following the Conference in September, the Officers & Directors put together a rough outline of priorities, items which we wanted to focus on to begin the year. Some of these you'll hear more about from Executive Manager Jones as a follow up to the meeting with the DVFA and the Governor on December 2.

PTSD, Mental Health – this was brought up at Conference. If you begin to search, there are any number of programs offered, such as the International Association of Fire Firefighters "Behavioral Health Awareness Courses" and the National Volunteer Firefighter's Council "Share the Load" program. The goal here is to utilize and build upon things already in place and to not "re-create the wheel".

Sustainable Funding – started with a discussion at conference involving all three counties. So far, this "committee" has met twice with some good discussion on how each County is funded and possible initiatives moving forward. Working in conjunction with the Resources Committees already in place in each County.

- Requesting to make this an official committee under the DVFA

Volunteer Firefighter Death Benefits – Deb Lawhead to lead this effort

- Determine and document "reasonable costs" associated with the death benefits for eligible volunteers

# **Committee Reports**

#### **State Fire Prevention Commission – Ron Marvel:**

The following are the highlights of the September, October, and November Fire Commission meetings.

- To date the suspected overdose deaths in Delaware is 307. There continues to be a high rate of calls and Naloxone use for overdose. All BLS agencies currently carrying naloxone can contact OEMS for naloxone re-supply as needed. Naloxone usage needs to be reported in the PCRs. New Protocol dosing has changed for Naloxone from 1 milligram to 1 to 2 milligrams for BLS during the opiate overdose. This was suggested by the BLS Protocol Committee as a more effective dose.
- PPE: Please continue to follow guidance as per the Department of Health. Any updates to guidance will be distributed to EMS agencies. Continue to make every effort to mask patients if they are not masked already. Despite some restrictions being lifted, there are no changes to EMS or healthcare PPE guidelines at this point. You can reach out to OEMS if you have PPE needs.
- The Commission made a motion to accept Consent Agreements for case numbers 2201 and 2207.
- The Commission requested Townsend and Minquadale Fire Companies to appear at the September meeting after not appearing as requested at the August meeting to discuss the reasons for late DFIRS Report submissions. They were requested to present a corrective action plan moving forward. The Commission agreed to have future conversations about reporting non-compliance.
- The Commission made a motion to accept the updated Ambulance Equipment list. The updated form can be found on the Commission's website.
- The annual Chair and Vice Chair elections were held. Ronald Marvel was elected as Chairperson for the Fire Prevention Commission. William (Bill) Kelly was elected as Vice Chairperson.
- The Commission has formed an EMS Committee to focus on some of the statewide needs surrounding EMS. Recruitment and funding will be some of the topics of focus.
- The 193 Committee has met and completed the Regulation 709 update. It is being prepared for public comment and the public hearing.

#### Advisory to DSFM – Grover Ingle: (copied and pasted from written report)

- Fire Fatalities There are 18 fire fatalities for 2022. Working smoke alarms were present in seven (7) incidents and 11 incidents had no working smoke alarms. No fire sprinklers were present in any of these incidents nor were they required by code to be installed at the time of construction.
- Deputy Fire Marshal I New Castle County Current vacancy position was reposted and will close on December 12, 2022, at midnight. Once we receive the list of qualified applicants the process will begin and probably take two three months to complete.
- Fire Protection Specialist I Sussex County Fire Protection Specialist II Dennett Pridgeon retired after 28 1/2 years on October 31, 2022. Currently in the process of selecting a candidate for this position and it is intended to have a person onboard by midJanuary or February at the latest.
- Administrative Specialist I Kent County /Sussex County As a result of a resignation from Administrative Specialist I Joy Fleming in Kent County on November 5, 2022, and the recent retirement of Administrative Specialist I LuAnn James in Sussex County on November 30, 2022, there are two vacant positions. Recruitment posting has closed for Kent County and Sussex County will close on December 13, 2022. Kent County applicants are currently in the interview process with the intention to have a selection by mid-January or February at the latest. Sussex will start the interviews once a list is received and hopefully have a person selected by mid-January or February next year.
- New Arson Van the Arson Van ordered in September 2021 from LDV is currently in the process of being built. Two staff members visited LDV for a construction inspection On December 5 & 6 and we look to take delivery after a final inspection in the first quarter of next year.
- DFIRS Continue to work with each Fire Company/Department on current data submissions to DFIRS.
   Significant Improvements have been made by the Fire Companies/Departments in submitting the data on time.
- The Office of the State Fire Marshal wishes everyone a happy and safe holiday season and look forward to working with the new officers in 2023.

#### Advisory to DSFS – Tucker Dempsey: (copied and pasted from written report)

- We will be holding interviews this week for our Deputy Director position and that will open a Training Administrator position.
- The three county EMT classes are wrapping up this weekend with their practical skills evaluations.
- We have bought our first Virtual Reality headset and we will be using it in our command simulation classes.
- The Americorps program is developing slowly. The job posting has been out for a while, but no applicants yet. We also haven't figured out how to pay them yet either.
- The Tuition Reimbursement program is going well.
- We are a few weeks into the latest Wilmington FD recruit academy.
- We will be holding a summer fire academy in 2023.
- We are working with Public Health and the Commission on Health & Wellness initiatives.

#### Final Conference report – Ray Stevens: (copied from written report)

1. Closing of Books for 2022 Conference:

On November 25<sup>th</sup>, I closed the books for Conference 2022. All receipts have been deposited and all bills have been paid.

2. Conference Revenues:

Actual Conference revenues came in at \$169,889. We also transferred an additional \$20,000 from the M/Mkt. account to help pay Chase their initial deposit, thus giving us working capital of \$189,889.

3. Revenues:

The **two big ticket items** this year that helped was:

Exhibitors \$15,000 Partners-in-Progress (both) \$83,052 Combined revenue: \$98,052

Equals: 57% of total Conf. revenues

4. Conference 2022 Expenses:

Total Conference expenses came in at \$175,246, thus giving us a surplus 0f \$14,643

5. Conference Expenses:

Nearly all of the social events came in under budget, including the Men's luncheon, Past Presidents banquet, Fire Chief's banquet, Fire Police Banquet, and the Ladies hospitality night. The Ladies luncheon just missed coming in under budget by just \$232.

6. Conference Expenses: Chase on the Riverfront

This is the timeline the Commission DAG has recommended to us to follow:

12/20/22 Fire Commission votes to adopt proposed changes to 709 and signs order re same.

1/15/23 Deadline to submit order and proposed amendments to 709 to Register of Regulations (ROR) for publication in February's edition of the ROR

2/1/23 Proposed changes and order published in February ROR. Must provide for a 30-day comment period.

3/2/23 30-Day public comment period expires. Commission to collect and distribute all comments received during official comment period (2/1-3/2).

3/21/23 Commission considers public comments and votes to finalize proposed changes to 709. Assuming no further substantive changes, final changes with order sent to ROR for final publication in May edition. Regulations would be effective 5/10/23 (law requires minimum of 10 days before regs can be effective; also note that 3/21 is past the fifteenth of the month, so can't get it to ROR for April edition; if we have special meeting sometime between 3/2 and 3/21, could possibly get them in April edition to be effective 4/10/23).

5/1/23 Target date for publication of final changes.

5/10/23 Reg changes are final and enforceable.
