Special Guest

Senator Bruce Ennis gave a report for the law and legislative committee, since he had to leave for another engagement.

- SB 89 which is the Health and Social Services food manager bill is still in committee. Hope to have it out on Tuesday for a vote.
- SB91 which would allow Medicaid transport vehicles to have stretchers or cots in their units for the patients.
- HB41 which is the surf fishing tags for the ladies auxiliaries is still in committee. Parks and Recreation is having a problem with this bill.

- HB133 which is the residential sprinkler bill passed the House on Thursday. Need to get it through the Senate.
- Appears to be a \$2 million deficit in the budget process. There will be some big cuts in the Grant in Aid programs, but they plan to leave the fire service, the veterans and the Cheer programs intact for now.

Ron Sarnicki, Executive Director of the National Fallen Firefighter's Foundation gave a brief report on the activities of the Foundation and what some of their upcoming events will be. He thanked the DVFA for their support of the Foundation and for their support at Emmittsburg during the National Fallen Firefighter Week-end. Ron gave info leading up to the smoke detector program, which was the main focus of their visit today. With all of that, Ron presented the DVFA with 200 smoke detectors with the 10 year batteries. Ron turned the microphone over to Neal Zipser, Community Affairs Manager of Kidde Fire Safety for his comments. Again, Neal thanked the DVFA for their work in the smoke detector program and wants to continue our partnership.

Report of Officers

President Guzzo: Full report has been filed electronically with the office. He highlighted several items that are in his report;

- He thanked everyone for their attendance at firefighter day at Legislative Hall

- President Guzzo has attended 35 events/functions, traveled 3,715 miles and spent 194.5 hours in service since our March meeting

First Vice President Zeroles: Full report has been filed electronically with the office. He has attended 24 events/functions for a total of 221.5 hours

Second Vice President Walius: Full report has been filed electronically with the office. He has attended 26 events/functions, traveled 3.500 miles and was in service for 275 hours

Secretary Steele: Full report has been filed electronically with the office. He has attended 28 events/functions, traveled 3,730 and was in service for 114 hours, plus 7 ½ days for FDIC and Del-Mar-Va Convention. I would like to wish everyone a happy and safe summer.

Treasurer Metheny: It gives me great pleasure to present the Treasurer's report for the period of March 7, 2015 through June 2, 2015. This report includes both the DVFA Operations and the Conference Account balances. As noted in the financial report, the Conference account balance is \$70.569.59 and the Operations account balance is \$391,000.78. I will prepare the necessary reports for the annual audit and will work with the Officers to prepare a budget for fiscal 2016. Dues notices in the amount of \$3,500.00 will go out on July 1st. There is a copy of the Conference budget in your packet today. Money from the Conference investment account and also money from the operations account in the amount of \$46,350.00 will need to be transferred

to balance the 2015 Conference budget. We will need a motion under the proper order of business to transfer these funds. I wish everyone a safe and fun-filled summer.

Motion by Stephen Maichle and seconded by Jasper Lakey to except the Officer reports. Motion carried

Executive Manager Jones discussed several issues;

- Thanked everyone that attended legislative hall on Thursday for the vote on HB133
- Only 7 more days for this years legislative session. Time is getting short
- Most of the Conference forms are on line. Please open up the form, fill out the necessary information, save the form to a folder and either send the form by e-mail to the office or download the completed form and mail it to the office
- Registration up-dates will be posted each Friday, so you can check to make sure you a registered for your particular event/function
- Warren gave an detailed picture as to where we are with the insurance rebate funds, from the inception of this issue up to the present time. Warren turned the microphone over to the DVFA Attorney Bill Preston to discuss where we are and what we should do next

DVFA Legal Counsel Bill Preston;

- Bill thanked Warren for giving the details on the insurance funds and bringing everyone up to date as to where we are
- Bill has prepared an "agency agreement" that each fire company will need to sign, in order for the DVFA and Bill to pursue litigation should this issue end up in court
- The DVFA cannot go to court without your permission, since the funds belong to the individual fire companies and not the DVFA. This form is for this one issue only
- There were several questions for Bill, as well as to the DVFA. There was a question as to how we were going to pay for the legal expenses, etc. The general consensus of the membership is that the DVFA pay the legal fees and that an assessment can be sent to each company if and when necessary

Committee Reports

State Fire Prevention Commission – Dave Roberts

- Dave introduced the commissioners that were present today.
- 46 ambulance inspections have been completed
- 96 uses of the Narcan program
- Commission re-appointed Fire Marshal Grover Ingle and Fire School Director Robert Newnam for another 4 year term
- Need numbers for the DEMSOC report
- Still working on the traffic fine money. About \$300,000 in that account now

<u> Advisory to State Fire Marshal – Grover Ingle</u>

- Still working on open positions
- 6 fire fatalities so far this year. 3 had working detectors and 3 did not

- Regulation up-dates. Most pertain to codes and wording
- HB133 requires the Fire Marshal's office to supply a brochure to the home builders that can be presented to the home buyer regarding the benefits of sprinkler systems

Commission Chairman Dave Roberts asked for a round of applause for Fire Marshal Ingle for his help and support on HB133

Advisory to DSFS - Robert P. Newnam

- Thanked Warren and the DVFA for their help with the budget process
- Still working on open positions
- Received a \$531,734.00 AFG grant. Will be used for up-dates and improvements
- New display cases have been installed in the hallway

- Motion by George Pyott and seconded by Rich Perillo to transfer \$46.350.00 to balance the 2015 Conference budget. Voice vote was close, so President Guzzo requested a roll call vote. Roll call vote shows 59 YES and 9 NO Motion carried
- Motion by Stephen Maichle and seconded by Richard Ward to cancel the Friday night dance at the Conference, due to cost and lack of participation. Motion carried

• Motion by Dan Burris and seconded by Richard Ward to have the DVFA pick-up the tab for the legal fees for the insurance rebate litigation and possible assessments could come later to each company based on the full cost. Motion carried
