Special Guest

Bill Webb, Congressional Fire Services Institute talked about the upcoming CFSI events to be held in Washington, DC on May 4, 5, 2016. He thanked the DVFA for its support in the past and hopes this will be another great year. The State of Delaware has received a \$30.00 discount on the price of the dinner tickets again this year. Total cost will be \$295.00 per ticket. The theme for dinner this year is "Making a Difference"

Bill gave a brief report on what the CFSI has been involved in during 2015 and 2016 on Capitol Hill.

Report of Officers

President Zeroles: Full report has been filed electronically with the office. He highlighted several items that are in his report;

- The JFC hearing was held on February 22 at Legislative Hall. Very good turn-out from the fire service. Warren did an excellent power point presentation.
- Thanked the various fire companies for their hospitality during the past few months as he attended their banquets, dinners and social events.
- He has attended 40 functions, traveled 2,246 miles and was in service for 159.5 hours.

First Vice President Walius: Full report has been filed electronically with the office. He has attended 32 functions, traveled 1,680 miles and was in service for 106 hours.

Second Vice President Perillo: Full report has been filed electronically with the office. He has attended 18 functions, traveled 1,594.6 miles and was in service for 86 hours.

Secretary Steele: Full report has been filed electronically with the office. He has attended 31 functions, traveled 2,540 miles and was in service 128 hours.

Treasurer Metheny: It gives me great pleasure to present the Treasurer's report for the period December 11, 2015 through March 8, 2016. This report includes both the DVFA Operations and the Conference Account Balances.

On March 1, 2016, I transferred \$1,915,287.33 to Northern Trust Company for our Calendar Year 2015 DVFA pension program. This consisted of \$1,761,147.33 for the employers share and \$154,140.00 to cover 2,575 fire company and ladies auxiliary members.

Allen also gave the Conference 2015 final report. The 2015 Conference cost us \$49,634.95 more than what we actually received.

Motion by Stephen Maichle and seconded by Jim Watson to except the Officer reports. Motion carried

Executive Manager Jones discussed several issues;

- Reported on the JFC presentation that was held on February 22, 2016. We asked to be placed in a separate bill for funding and no longer with the rest of Grant in Aid. We also asked for funding for tactical ballistic vest for our EMT's and firefighters. The JFC committee was very attentive to our presentation. Thanks to everyone that attended the hearing, the turnout was great.
- Reported on a smoke detector program that may be funded by the Controller Generals Office in the amount of \$200,000.00 This money would be coming from mortgage settlement money. They have asked that we identify needed areas of the State, canvas these areas to see who needs smoke detectors and install the detectors. Discussed getting other community groups involved in this project, due to limited man power to go door to door to accomplish their goal. The JFC met last week to discuss how to best use the balance of the settlement money. The \$200,000.00 for smoke detectors was still on the

list, along with several other projects. The JFC did not make any final decision at that time.

- Discussed HB 218 related to selling of ground-based and hand held sparklers and other non-explosive, non-airborne novelty fireworks within the State. The bill does not legalize firecrackers, bottle rockets, aerials or any other device that explodes or shoots into the air. The use of these items may be sold to persons 18 years of age and older and is limited to July 4th and December 31st of each year and sales are limited to the 30 days prior to the allowable use day. This bill is being revised, so we are not able to take a position on it until we see the finished bill.
- The Leadership symposium is April 9th. We will be handing out a packet for each fire company containing important information and a check list. Would like to have someone from every company. Registrations are coming in very slow. Deadline is March 26th. We will review the registrations next week and may be able to open it up to anyone that wants to attend, even though the event is geared towards current officers. The keynote speaker is Chief Richard Gasaway. He is a great speaker and very knowledgeable fire service personality.
- The Delaware 87'ers basketball team is sponsoring an American Heroes Night on March 25, 2016 at the Bob Carpenter Center. Info is on the front table.

Committee Reports

<u>State Fire Prevention Commission – Dave Roberts</u>

- Dave introduced the commissioners that were present today.
- Still needs annual BLS reports from the companies
- Traffic fine money has been distributed totaling \$919.000.00. A total of \$1,500,000.00 has been distributed since the program started.
- Scratch rate has been reviewed and has been dropped from 10% to a new rate of 9%

Advisory to State Fire Marshal – Grover Ingle

- Fire Deaths: Currently there are four (4) fire deaths. No working smoke alarms in either of the four (4) deaths
- The Deputy Fire Marshal I, vacant position for Kent County Division is still in the hiring process. Hope to have someone on staff in April or early May
- Administrative Specialist I: Vacancy to be posted in the next week.
- Deputy Fire Marshal I, Just completed interviews the first week of March, moving forward with background checks
- Fire Protection Specialist I, vacancy in Sussex County, interviews on March 14 and 15
- FY 2017 budget: Completed JFC hearing on February 22, 2016
- Continuing to work with the fire companies on their DFIRS reports
- 2015 State Fire Prevention regulations went into effect on March 11, 2016
- Will be meeting with the home builders association regarding the brochure/informational requirements and the distribution of the printed pamphlets

• Mike Lowe added that the DFIRS reports in Delaware are much higher than other States and that the Fire Marshal's office should be commended for their work with DFIRS. Delaware rate of return is 85 to 87%.

Advisory to DSFS – Robert P. Newnam

- EMT re-certification is in process. 404 are due by the by March 31
- There are 1,510 EMT's in the State
- Student numbers for all classes are up
- School is reviewing the EMS up-dates regarding the new proposed standards. The school will be making some suggestions to the new standards
- Doing class room up-dates
- April 3 is the ladies seminar. Hope to have another good turn out
- Chad Ingram is the newest senior instructor

DVFA Conference– John McKenzie

- Working on various changes to reduce to cost of the Conference

• Cardio Kinetics program is working well. Almost out of money, will be searching for more funding for the program

Law & Legislative – Ed Barlow

- Thanked Warren for the good report and power point presentation that was made at the JFC hearing
- Bruce added that there needs to be some consensus regarding HB 218.
- Bruce also discussed the possibility of having the Department of Motor Vehicle issue ID cards for Fire Police

<u>Life Safety – Guy Hudson</u>

- Thanked everyone that attended the 2015 awards program in Cheswold in January. There were 29 of the 31 award winners in attendance
- Had 36 requests totaling \$140,702.58 for matching funds for this year
- The changes for the 2016 program have been approved and will go to the printers soon

Recruitment & Retention - Earle Dempsey

- Awarded 17 SAFER sub-grants this year totaling \$46,400.00
- R & R open house at the various fire stations will be May 14th
- Working with the State Fair to co-sponsor the monster truck show this year on July 23rd

<u> Permanent Memorial – Jim Watson</u>

- Site of the new monument has been moved to the South east corner of the Mall, due to some problems with trees on the proposed North side of the Mall. Should have final approval of this move on March 16th. A power point presentation was made, which brought out several questions. Most of the concerns were addressed during the presentation, but a couple will need more review.
- Ray Stevens gave a report on the funding that has been received thus far. 16 of the 21 New Castle County companies have sent in their \$1,000.00 donation, 9 of the 18 Kent County companies have sent in their \$1,000.00 donation, 10 of the 21 Sussex County companies have sent in their \$1,000.00 donation. Several other organizations and associations have also made donations. The total received thus far is \$43,510.00
