Bob served on the Board of Directors of the Delaware Better Business Bureau, served on the Board of Directors of the Pennsylvania Atlantic Seaboard Hardware Association, served as President of the Delamarva FIFE Federal Credit Union, served as President of the Harrington Jaycees, a member of the Loyal Order of Moose, a member of the Harrington Lions Club and a Board member of the Delaware State Fair. He is also a member of the Asbury United Methodist Church. He has been married to his wife Betty for over 50 years and has raised 3 children. His son Rob has followed in his father's footsteps and is a Past President of the Company and currently is Ambulance Captain and 1st Assistant Chief of Harrington Fire Co.

LADVFA Past Presidents Carol Walton, Penny Rodimak and Saralee Stevens brought greetings from the Ladies Association on behalf of President Majewski who will be coming to our luncheon on Friday with a full report of their activities for the year.

REPORT OF THE OFFICERS

President Anthony Guzzo: The President thanked the officers and everyone in the audience for their support this past year. It takes everyone working together to get things done and again I want to thank all of you. Some numbers to report; attended 151 events/functions this year, traveled 14,931 miles and spent 863 ½ hours in service. At this time I would like to have Ray Stevens, Steve Austin, Jim Watson and John Lattomus to come to the stage. While they were making their way to the stage, President Guzzo asked that all of the table officers please stand while he made a presentation to these gentlemen. President Guzzo presented checks to each of these gentlemen on behalf of the 2015 DVFA officers for the DVFA Foundation, the Scholarship fund, the Memorial fund and the Delaware Burn Camp.

1st Vice President Joe Zeroles: Stated that his report was in electronic form and filed with the office. He thanked everyone for a great year and looking forward to everyone's help and support in the coming year. Numbers for the 4th quarter; 28 events/functions and in service for 142 ½ hours

2nd Vice President Ted Walius: Stated that his report was in electronic form and filed with the office. He thanked everyone for a great year and is looking forward to the coming year. Numbers for the 4th quarter are; 28 events/functions, traveled 1,535 miles and in service for 117 hours.

Secretary Elmer Steele: Stated that his report was also in electronic form and filed with the office. During the 4th quarter, Secretary Steele has attended 33 functions, spent 155 hours in service and traveled 2,800 miles. His final totals for the 2014-2015 year were; attended 107 functions, spent 461 hours in service and traveled 10,440 miles while representing the DVFA. Looking forward to another great year.

Treasurer J. Allen Metheny: Thanked the officers for another great year and look forward to the coming year with the new officers. He gave the financial report for the Association and for the conference accounts. This info is in your packets for your review. Books have been audited by our CPA firm and all is well. Total assets of all the Conference accounts is \$202,070.39 and total assets of all the DVFA accounts is \$428,006.80 Look forward to serving another year as the Treasurer of the Association.

Executive Manager Warren Jones: Warren gave a report on the legislative session for the past year. Warren talked about the Grant in Aid with regards as to how we get our funding and what is being looked at for the future. A committee will meet with the chairs of the JFC, the Controller General, OMB and two of our legislators to talk about the direction of our funding. Warren discussed SB 207 pertaining to the formula for calculating the cost of an ambulance run. The form and instructions are on the DVFA web site. You need to down load this info and take it to your accountant. Warren also discussed the insurance premium issue that took place in April, 2015 regarding the \$953,757.02 that was to be taken from the 3 Counties and given to the City of Wilmington. The insurance commissioner has stated that this is a done deal, there will be no reduction in the 3 Counties funding this year and we will get full funding in October. He thanked everyone for their support to the office this past year. There has been a reduction in office staff this year, but he feels that everything is working well.

Introduction of Out-of-State Guest: Steve Austin introduced the Out of State guests that were in attendance this morning;

- Virginia State Firefighter's Association (VSFA) President Jeff Flippo brought greetings from the Commonwealth of Virginia.
- Cumberland Valley Volunteer Firemen's Association (CVVFA) President Hoby Howell brought greetings from their Association. CVVFA just completed their Convention in August and Hoby thanked the group from Delaware for hosting the 2015 Convention in Delaware City. Introduced other officers that were in attendance.
- Maryland State Firemen's Association (MSFA) Past President Bob Cumberland brought greetings from the State of Maryland on behalf of President Johnie Roth. Introduced other officers and Past Presidents that were in attendance.
- Eastern Director of IAFC Terry Jester brought greetings from the IAFC. Discussed several things that the Eastern Division is doing this year.
- Delmarva Firemen's Association Past President Elmer Steele thanked this Association for their support. He stated that there were several officers from Delmarva in the room today.

DVFA Foundation: Steve Austin gave a brief report as to the activities of the foundation. They are seeking grants again this year.

Delaware State Fire Prevention Commission: Chairman Dave Roberts introduced the commissioners that were in attendance. Dave stated that there has been \$579,901.00 dispersed from the traffic fines in the first payments. He thanked President Guzzo on a great year and welcomed him as a new commissioner.

Delaware State Fire Marshal: Fire Marshal Grover Ingle's written report;

- Fire Deaths Currently, there are seven (7) fire deaths, four (4) with a working smoke alarm and three (3) without a working smoke alarm. This year's theme for Fire Prevention week (October 4-10, 2015) once again is most fitting "Hear the Beep Where You Sleep". Every bedroom needs a working smoke alarm.
- The Deputy Fire Marshal I, vacant position for Kent County Division should be posted within the next couple of days, as well as the vacant Administrative Specialist I position for New Castle County Division.
- FY2017 Budget The Office of the State Fire Marshal will be seeking to maintain our current level of funding with a minimal increase to complete the transition of agency owned vehicles to fleet vehicles. Our budget target meeting has been rescheduled to September 29, 2015 at 3:30 PM at DSFS and the public budget hearing is scheduled for November 4, 2015 at 11:30 in the Senate Chambers.
- Annual report has been completed and distributed to the Commission, President's, Fire Chief's, Governor, the legislature and other associations, as well as being on our website. Congratulations to the Staff for their hard work throughout the year.
- DFIRS reports We continue to work with each Company on their submittals and cleaning up the data. The annual report reflects the information provided by the Fire Departments/Companies for the calendar year 2014.
- At the State Fire Prevention meeting on Tuesday, September 22, 2015 at 10:00 AM there will be a public hearing on the proposed 2015 State Fire Prevention Regulations.
- Regarding the residential sprinkler brochure/informational requirements, I have met with the home builder's regarding the brochure and hope to have a document ready for January 2016.

- Congratulations to President Guzzo on a successful year and we look forward to working with incoming President Zeroles and his Officer's during the upcoming year.
- Congratulations to President Machle from the State Fire Chief's Association for a successful year and we also look forward to working with President Pennington and his Officer's in the coming year.

Delaware State Fire School: Director Robert Newnam thanked the DVFA table officers, the Advisory committee, the 1st responders and the office staff for their support to the school this past year. Thanked Warren Jones for his help with the various legislative issues and the fire Commission for their support on EMS issues. Biff stated that they received an AFG grant to purchase a fire truck for the school. Student surveys are on line. There are 1440 EMT's in the State.

National Volunteer Fire Council: J. Allen Metheny stated that the Council is working on several issues that affect the fire service.

Delaware State Fire Chief's Association: President Stephen "Redman" Maichle brought greetings from their Association. Thanked everyone for their support this past year. Billy Goldfeder will be the guest speaker tonight at the Conference meeting in Cheswold.

Delaware State Fire Police Association: President Charles Morgan not in attendance.

Delaware State Emergency Medical Services Association: New President Jennifer Knox brought greetings from the State EMS Association.

Mutual Relief Association: Chairman Rich Weaver stated that there will be a vote taken today to re-new the Mutual Relief insurance policy and to accept or reject the AD&D policy. Please have your delegates/alternates at the meeting.
